

School Fees - 2025

Primary School – Kindergarten to Year 6

Enrolment Fee:

A non-refundable enrolment fee of \$750 is payable to cover administration costs for each new K-6 enrolment.

Security Bond:

Upon enrolment, a security bond is payable for each student. For students in Kindergarten to Year 6, the security bond is equivalent to one Term's fees. In 2025, the security bond for Kindergarten to Year 2 is \$3179.50, and \$3295.50 for Years 3-6. Security bonds are placed in a trust account and returned to families upon request when a child leaves the school and all accounts have been settled.

Tax Deductible Voluntary Building Fund:

\$680

Notification of withdrawal from school is a requirement in independent schools.

The Italian Bilingual School's enrolment conditions require parents to provide the Executive Principal with a minimum of 3 months (one Term's) written notice of the withdrawal of the Student from the Preps Program, before the proposed withdrawal date. Failure to do so will result in one Term's tuition fee being invoiced to the family account. (Clauses 9.1 and 9.2 Italian Bilingual School Enrolment conditions)

Payment of Fees:

Tuition fees may be paid in either of the following ways:

1. Full payment of yearly fee in advance

In 2025, a discount of 2% is applicable for upfront payments.

Discount of 10% applies for the second sibling (Kindergarten -Year 6) of the base fee

Discount of 15% applies for the third sibling (Kindergarten -Year 6) of the base fee

Discount of 20% applies for the fourth sibling (Kindergarten – Year 6) of the base fee

2. Payment in 21 direct debited equal instalments.

Failure to pay due fees will incur a 5% penalty fee and may ultimately jeopardise your child's enrolment. In the event of financial hardship, please approach the Executive Principal as a matter of urgency.



Overseas Student School Fees - 2025

Preps:

\$115 per day

Enrolment Fee:

A non-refundable enrolment fee of \$750 is payable for each student upon enrolment.

Security Bond:

A security bond of \$3750 (K – 6) is payable for each student upon enrolment. The bond will be placed in a trust account and will be returned upon the parent/guardian's request when the child leaves the school and when all accounts have been settled.
